

Warranty, Copyright, Safety Notices

LIMITED WARRANTY. Polycorn warrants to the end user ("Customer") that this product will be free from defects in workmanship and materials, under normal use and service, for one year from the date of purchase from Polycorn or its authorized reseller.

Polycorn's sole obligation under this express warranty shall be, at Polycorn's option and expense, to repair the defective product or part, deliver to Customer an equivalent product or part to replace the defective item, or if neither of the two foregoing options are reasonably available, Polycorn may, on its sole discretion, refund to Customer the purchase price paid for the defective product. All products that are replaced will become the property of Polycorn. Replacement products or parts may be new or reconditioned. Polycorn warrants any replaced or repaired product or part for ninety (90) days from shipment, or the remainder of the initial warranty period, whichever is longer.

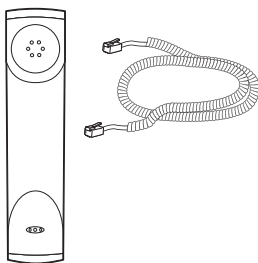

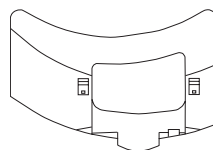

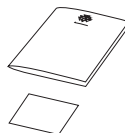

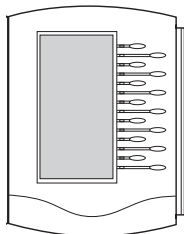

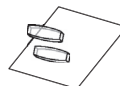

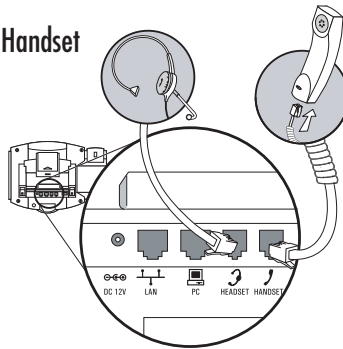

① Connecting Headset and Handset

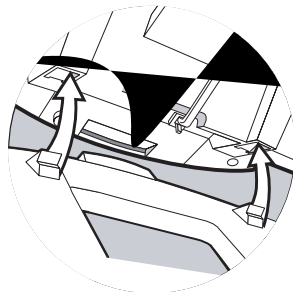


② Connecting Network and Power

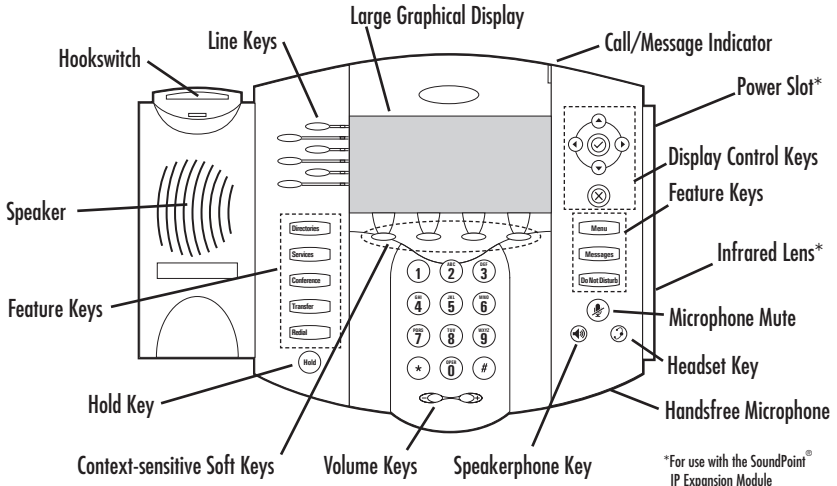
